(a) Degree of Disability for Reservation:

Under Section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995 only such persons would be eligible for reservation in services / posts who suffer from not less than 40% of relevant disability and is certified by a Medical Board appointed by the Central/State Govt. (iii) Visually Impaired (VI): The visually impaired persons are those suffering from blindness or low vision.
