**ORDER**

Whereas, the process of online counseling for admission into the 1<sup>st</sup> Year of degree level Engineering & Technology including Pharmacy Colleges of the State conducted by the West Bengal Joint Entrance Examinations Board (WBJEEB) under the aegis of this Department for the academic year 2012 - 13 based on the results of JEM - 2012 for Engineering is already underway, vide this Department's order bearing no. 239/Edn(T) dated 5th June, 2012;

And whereas, the said process of online counseling has also been governed by the subsequent orders of modifications issued by this Department on subsequent occasions;

And whereas, the process of online counseling has already completed two rounds of allotment of seats amongst eligible registered candidates through the process of e-Counseling and the results of the third round is due on 25<sup>th</sup> of July, 2012;

And whereas, it has been ascertained by the State Government in the Department of Higher Education that the revised schedule of actual admission at the Participating Institutes' level i.e. the institutes of Engineering and Technology wherein the students will pursue their studies w.e.f. 29<sup>th</sup> July, 2012 up till 31<sup>st</sup> July, 2012 would not be enough for smooth completion of such admission process which ought to be completed by 31<sup>st</sup> July, 2012 as per order of the Hon'ble Supreme Court of India;

And whereas, it has also been envisaged by the State Government in the Department of Higher Education that aforesaid dates of the said admission process at the respective Participating Institutes' level as per the last revised schedule, now requires modification in public interest;

Now therefore, the State Government in this Department of Higher Education has decided to modify the remaining e-Counseling Schedule which stands modified as annexed herewith wherein it is made to be understood that the *already upgraded and finally allotted students along with such students who had not opted for upgradation in the first place or subsequently stalled the process of upgradation in the subsequent rounds may now attend their respective finally allotted institutes w.e.f. 26<sup>th</sup> July, 2012 for actual admission at the institute level instead of 29<sup>th</sup> July, 2012 as mentioned in the last government order vide no. 290-Edn(T) dated 18<sup>th</sup> July, 2012.*

Furthermore, the State Government in this Department of Higher Education has decided to enumerate the following guidelines for actual admission at the respective Participating Institute on the basis of existing government orders including the order for *revised fee structure for the self-financing engineering and technological institutes* vide no. 246 - Edn(T)/10M - 04/2004(Part IV) dated 06<sup>th</sup> June, 2012.

1. All the Participating Institutes shall abide by the following Government Orders and Notices vide:
  - a. No. 239-Edn(T) dated 05<sup>th</sup> June, 2012 and subsequent orders on different dates pertaining to *online admission through e-Counseling - 2012 including this instant order*;
  - b. No. 246 - Edn(T)/10M - 04/2004(Part IV) dated 06<sup>th</sup> June, 2012 on *revised fee structure for the self-financing engineering and technological institutes*;
  - c. No. WBE/GL-142 (Corrigendum) dated 19<sup>th</sup> July, 2012 regarding *withdrawal, refund and adjustment of fees*;
2. *No institute shall charge any fees except in consonance with the aforementioned govt. orders*;
3. The admission fees collected by the WBJEEB shall be extended to the institutes in due course.

All concerned are being informed accordingly for compliance.
