Title: Certificate Course in Predictive Homoeopathy VISION:

To empower Homoeopathic Physicians with recent developments in the field of Predictive Homoeopathy and improve their proficiency, knowledge and ability to manage patients clinically by allowing them to have an experience of the highest order of excellence, which can be applied into their practice from day 1, after they complete the Certificate Program.

INTRODUCTION:

Certificate course in Predictive Homoeopathy is an additional qualification which accentuates the physician's clinical expertise and takes him to the next level of success and confidence. The Syllabus has been formatted to be a value addition to what has already been learnt by the doctor during graduation and post graduation and has to be directed to the practical applications of the concept of Predictive Homoeopathy.

Predictive homoeopathy is based on Hahnemann's Organon and especially on Hering's Law of Cure; which allows the application of modern scientific knowledge in the area of Physiology, Embryology, Genetics and Immunology. It is the successful implementation of Homoeopathic principles and continuous achievement of expected and precisely defined Homoeopathic therapy results.

NEED FOR THE COURSE:

It is mandatory for opportunities to be created for adequate patient exposure. There are also a considerable number of medical / homoeopathic practitioners in India who are interested in learning Predictive Homoeopathy but who do not have access to any course recognized by a scientific body where they can get exposure to it as an application of Homoeopathy and get knowledge and clinical experience. A Health Science Course on Predictive Homoeopathy needs not only classroom instruction but a lot of training in observation, case taking and data processing methods. It should be clear that the purpose of the study is to equip the physician with a Philosophy and a Method and not cram him with facts that are possible to refer to in various books. At the end of six months period of study, they should be in a position to understand the applied aspects of Predictive Homoeopathy. This exposure would lead to an intensive application at the bedside / in clinics. The exercises too are designed to help the candidate handle this experience.

AIMS, OBJECTIVES AND DESIRABILITY:

This course, would demonstrate the application of Predictive Homoeopathy in different clinical conditions spanning Medicine, Orthopedics, Rheumatology, Allergy, Dermatology, Respiratory Medicine, Psychiatry, Surgery and Gynecology-Obstetrics, etc. It would illustrate the application in Inpatient Care and in the Management of Acute Conditions and chronic conditions efficiently and effectively. Its expertise is to treat difficult cases and repeat good result in most of them.

It needs an understanding of the Physiology, Embryology, Genetics, Immunology, clinical, pathological and immune miasmatic states of different diseases by which the approach to different diseases with management can be decided. This will give access for polishing the skills of the individual doctors making them more proficient.

The broad objectives are:

1. Improving the skills of the Homoeopathic Physician in dealing with cases esp. Case taking and dealing with various types of patients in different illnesses with the concept of Predictive Homoeopathy.

2. Rationalizing and Standardizing the approach of Predictive Homoeopathy towards cases.

3. Exposure to live cases and hands on training to boost the confidence of the Homoeopathic Physician

4. Integration of classical learning with the newer visions or methodology or approach of Predictive homoeopathy.

5. It can also be used to integrate any or all of this learning into application in specific disease complex or systems like autoimmune Disorders, Allergy, Locomotor Diseases, Neurology, Paediatric, Dermatology, Cancer, HIV, Addiction, Psychiatry, etc.

6. The mentors & teachers would get opportunity to transfer their knowledge and take 100s of students to the higher level of excellence through training them in their respective field of interest with advanced knowledge & with Clinical skills related to Predictive Homoeopathy

ELIGIBILITY FOR ADMISSION:

1. Post Graduation, M.D. (Homoeopathy)

OR

2. Teachers having 5 years approved teaching experience.

OR

3. Homoeopathic practitioners having minimum 10 years of professional experience.

INTAKE CAPACITY:

1. Maximum of 25 students per batch provided there is an adequate mentor-student ratio which should be 1:3

2. Intake can be taken twice a year.

FEES:

1. Rs. 10,000 for the Certificate Course inclusive of the monitoring of case assignments

2. Exam fees as per the University rules & regulations.

COMMENCEMENT OF COURSE:

Course would start from the 15th January and 15th July of every year.

DURATION:

Total duration would be 6 months.

FACULTY:

VACATION:

To be decided by the Dean as per the need of the batch or course. These details to be informed to the University immediately whenever they submit the Academic Programme the beginning of the course.

CREDITS: Student should have minimum of 150 points to be eligible for final exams and 200 points to acquire the certificate

- 1. Lectures Each 3 Hrs will attract 1 Credit point (maximum of 40 points)
- 2. Presentations 1 Credit point for 2 hours of Individual presentation (maximum) of 10 points)
- 3. Assignment 10 credit points.
- 4. Clinical Training Each 3 Hrs will attract 1 Credit point (maximum of 50 points)
- 6. Cases solved 1 credit points per case to be given by Guide/ co-guide/ Mentor (maximum of 15 points)
- 7. Internal assessment maximum of 25 credit points

EXAMINATION:

1. Examiner:

- a. Any mentor or teacher
- 2. Final exams will be conducted after 6 months from admission Completion of Course

Examination Assessment:

1. Ongoing Assessment – Throughout the course through – clinical cases, submissions, participations esp. of the following:

- a. Evaluation of knowledge of the subject/s
- b. Evaluation of Capacity to integrate
- c. Evaluation of Capacity to apply i.e. clinical abilities
- d. Evaluation of participations in presentations, discussions, workshops, seminars. Camps etc.

2. Assignments –

- a. Once a week 1 paper case/ video cases to be solved.
- b. Submitting 4 cases with follow ups video/paper case/over 6 months.
- 3. Written Exam on the subject which will be practical and case based

Results should be based on:

1. **Ongoing Assessment** – Credit points for overall performance in areas of – knowledge, integration, Application, discussions, and Participation (in Seminars/workshop/Camps)

2. Written Exam – One paper with 50 credit points of the subject at the end of the course, 25 being deemed fit for passing

3. Viva / Practical – 50 credit points which would involve case solving, discussion and skill achieved

To pass Examination: 50% of the credit points are mandatory.

RE-EXAMINATION:

- 1. Re-examination will be taken once in a 6 Months
- 2. If the Student fails, he/she will have to appear after 6 months by paying 10% of the actual course fees.
