For Availing Sport Scholarships the event must be recognized by any one of the following:

- Olympic games by IOC
- World championships under international sports federation (IOA and/or MYAS recognized/affiliated games).
- Asian games by Olympic Council of Asia.
- Asian championship organized by International Federation of concerned game (recognized/affiliated by MYAS and/or IOA).
- Commonwealth, SAF and Afro Asian games.
- Paralympics games (recognized /affiliated by IOC and/or MYAS)

Note:-

1. In absence of relevant sports certificates scholarship application will not be considered.
2. A certificate can be utilized by the candidate only once for any type of scholarship throughout the university stay.
3. A student who is found indulged directly or indirectly in a case of indiscipline in and around the university campus will not be eligible for any type of scholarship of the university in future.
4. If a student is found to have forged any necessary documentary proof, he /she will not be able to

avail any type of scholarship of the university in future.

5. No certificate of invited tournament in any of the games will be considered for the scholarship.
6. The student has to submit current year certificate for continuation of the scholarship.
7. Separate policy as approved by competent authority will be applicable to the students of sports education.

Category D: Scholarships for Military and Paramilitary Forces

- 10% scholarship on tuition fees to servicemen(The scholarship is not applicable to Ex-Servicemen).

Category E: Existing Student Benefit

- After completion of B.Sc. course if one seeks admission in M.Sc.will get relaxation of 10% of Program Fee in First year only.
- A Student of ITM University, Gwalior or ITM GOI, Gwalior taking admission in LLB program will be eligible for getting relaxation of 10% of program fee in first year only.
- If earning parent of a student of ITM university, Gwalior passes away, during the terms of the course, he/she will get relaxation of 50% in tuition fee per year.
- Real sibling scholarship will be given to one sibling till two or more real siblings are studying in ITM University, Gwalior. The amount will be 10% of the tuition fee in all other courses.
- Staff working in ITM University can avail a benefit of relaxation on tuition fee if their ward takes admission in ITM University as follows:-

Faculty	25% off on tuition fee per year
Class III and Class IV	50% of tuition fee per year

Scholarship on the basis of Humble Economic Background: The candidate has to submit supporting documents i.e. income certificate to earn the scholarship at the time of admission only for being eligible for the scholarship at entry level. However for the continuation of the scholarship, the candidate has to apply every year along with latest supporting documents. The number of students can be given this scholarship is up to 15% of the total admitted students in each course.

* **Students availing Scholarship on Economic background will not eligible for any other type of scholarship.** A candidate will be eligible to claim scholarship only if one produces valid income certificate and bank related statement and Income Tax Return.

* This scholarship shall be considered for continuation every year subject to submission of valid income certificate of current year.

General Rules for Awarding Scholarships:

The mentioned criteria are only the eligibility to apply for scholarship. Candidates fulfilling the eligibility are required to fill scholarship form. In absence of relevant & original mark sheets, the admission and scholarship application will not be considered. Final decision of granting scholarship is with the Admission Board and Scholarship Committee (for continuation of scholarship) of ITM University.

- Entry level scholarship will be adjusted in the fee of II semester. Other scholarships will be awarded during annual function.
- 2nd year onwards Chancellor's scholarship will be awarded based on merit of previous year results as per the University scholarship policy.
- Any student found involved in any act of indiscipline and/or practicing unfair means may be debarred from availing scholarship at anytime without any notice.
- The students fulfilling more than one eligibility criteria will be considered only as per higher preference mentioned in the scheme and will be eligible for only one type of scholarship in year. Under no circumstances any student will be sanctioned more than one scholarship or any other financial aid from the University.
- In case when beneficiary scores YGPA on basis of SGPA (two semesters of current academic year and no backlogs up to current semester) / Percentage in upper scholarship band, he/ she will be promoted to upper scholarship band for that year only, similarly for the lower scholarship band. A certificate can be utilized by the candidate only once for any type of scholarship throughout the university stay.
- If a student is found to have forged any necessary documentary proof, he /she will not be able to avail any type of scholarship of the university in future.
- No certificate of invited tournament in any of the games will be considered for the scholarship.

Policy for Continuation of Scholarship

- Chancellor Scholarship is granted every year on the basis of annual performance of a student in the university examination as per the scholarship policy.
